 - c. Interstate learning: Presentation of Washington County School District and Colorado City Unified School District agreement by Todd Gilmore. How can Fredonia Moccasin Unified School District utilize this information, and is such an agreement a possibility for FMUSD?
 - i. GF motioned to take closing of the high school off the table and working on being the best little school as possible: motioned died.
 - ii. GF motioned to take closing of the high school off the table and continue to pursue agreement with Kane County approved: DJ seconded, 4 to 1 voted in favor. DS opposed and wanted the two items voted on separately.
 - iii. MC motion to keep Fredonia High School open at this point passed: DS seconded, vote 3 to 2.
 - iv. GF motion for the cooperative agreement with Kane County failed: DJ seconded, 2 to 2 vote with one abstained.
 - v. GF motion to continue to persue developing agreement with Kane County failed: DJ seconded, 2 to 2 vote with 1 abstained.

- vi. GF motion to pursue a more specific understanding of what a framework would look like with Kane County passed: DJ seconded, 3 to1 with one abstaining.
- vii. MC motion to pursue programs that will expand opportunities died.
- viii. MC motion to direct administration to find ways to gather information on ways we can expand died.
- ix. DJ directed TG to send a letter by December 30 to determine community input on ways Fredonia High School can be a specialized school and have information ready to report by January's meeting.

- i. Native American Policies and Procedures (Impact Aid) passed unanimously: RC motioned, GF seconded.
- j. ASBA bylaw change approved: MC motioned, DS seconded, GF abstained. MC unanimously approved to submit vote: DS motioned, DJ seconded.
 - i. Proposal A With unanimous approval of the ASBA Hispanic Native American Indian Caucus and ASBA Board of Directors, this change is being sought by the Hispanic-Native American Indian Caucus (HNAIC). It would create a seat on the ASBA Board of Directors so that Hispanic and Native American interests can be represented simultaneously on the board. Currently, there is one seat on the ASBA Board of Directors designated for a representative of the HNAIC and it alternates every two Hispanic representation Native between and American representation, creating gaps in representation. By contract, the Black Alliance has a seat on the ASBA Board of Directors, ensuring representation on the board at all times. This proposed bylaw change also provides the flexibility for the HNAIC to split into two distinct groups if its members so choose and allows those groups to change their names and be recognized under the new names. Background: Currently, there is only one seat designated for the combined Hispanic Native American Indian Caucus.

Per FMUSD Policy CBI, Board Members have been provided with a copy of FMUSD Policies CBI and CBI-E (Exhibit) (available on the district website) outlining the duty of the board, evaluation instrument, and the timeline with which to evaluate the Superintendent yearly. Per policy, the board will set a date, before December 18, to hold an executive session (unless the superintendent requests the meeting be held publicly), to conduct said evaluation. Board unanimously approved a special meeting held December 14, 2021 at 6:00 for superintendent's evaluation: DJ motioned, GF seconded.
