 - i. Within fie days after a child enters foster care if a child's placement changes, the child, the child's caseworker. The child's parent, guardian, custodian, caregiver, or foster parent, and representative from the child's school or origin are required to determine if it is in the child's best interest to remain in the child's school of origin.

school or to a suspension for two or fewer days when the aggregate suspension for that student do not exceed ten days within the school year.
